<b>Gov 16-19 Bursary Fund</b>	This fund provides financial support of up to £1,200 for those in care, a care leaver or a receiver of certain benefits who study at a publicly-funded school or college or are on an unpaid training course. The bursary can help with education-related costs such as lunch, equipment, or transport to school/college.	
<b>The Actors Children's Trust</b>	To be eligible for ACT funding, the child must have a parent who is a professional actor Most ACT grants are for children up to GCSE age but there is also support for 16-18 year olds ACT does not pay for private school fees but can be used for uniform, trips and other needs.	<a href="http://actorschildren.org">ACT - The Actor's Children's Trust - Supporting the Children of Actors. <b>The Emmott Foundation</b>	Grants are made to students for their A-Level years in fee-paying schools. Students will normally have high academic standards. In exceptional cases where the need is demonstrably great, the trust will consider those with lower grades. <b>Ewelme Exhibition Endowment</b>	Bursary awards for applicants aged 11-18 and grants to those aged 11-25 and a resident in Oxfordshire, Berkshire, Buckinghamshire, Ramridge in Hampshire and Conock in Wiltshire. <b>Wispers Trust</b>	Pupils whose education in Years 11-12 (GCSE) or Years 12-13 (A2) would be compromised by parents or guardians being unable to pay the fees, through no fault of their own. <b>Archbishop Abbot's Exhibition Foundation Grants</b>	Grants offered to students between the ages of 11- 28 inclusive who are residents in Guildford or Waverley and can demonstrate financial need.	
<b>Black Heart Foundation Scholarships</b>	Scholarships are offered to students at any level of education, from primary school through to postgraduate study. They are intended to support students in the advancement of their education where they might otherwise not have been able to do so. To apply to the Black Heart Scholarship Programme, you need to submit an application of no more than 1200 words providing a brief summary of the educational activity for which you seek a scholarship, outlining how the scholarship would align with the aims of The Black Heart Foundation and presenting a clear case of financial need.	<a href="http://The Black Heart Foundation">SCHOLARSHIP PROGRAMME – The Black Heart Foundation</a>
<b>Gotranscript Scholarship</b>	Open to students either in the last year of school or the first of university. Applicants have to submit a short personal statement plus an essay on the following subject "Share a story about how language has helped you express your voice."	
<b>Ocean Estate Bursary</b>	Open to any student who is resident in the Ocean Estate in Canary Wharf/Tower Hamlets and starting a new further or higher education or training course.
